

Journey Partner Inc. Online Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to journeypartnerinc.org and Journey Partner Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Journey Partner Inc. include journeypartnerinc.org and JPI. The JPI website is a Spiritual Non-profit site. By using the JPI website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, JPI may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Facilitator Credentials

If you purchase JPI's products, services, or donate, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. Sharing Information with Third Parties

JPI does not sell, rent or lease its customer lists to third parties.

JPI may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are

prohibited from using your personal information except to provide these services to JPI, and they are required to maintain the confidentiality of your information.

JPI may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on JPI or the site; (b) protect and defend the rights or property of JPI; and/or (c) act under exigent circumstances to protect the personal safety of users of JPI, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by JPI. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the JPI website.
